

Those of you in the Willows and Redding clubs, please help us out at this event held on June 8-9-10 at Tehama County Fairgrounds in Red Bluff, CA.



New procedure to think about—the new **RGS** (Rules, Guidelines & Specifications) **booklet** is out. Each of your clubs has a copy , so if you want to see it, please ask your contact person.

In this RGS book there are qualifications for me, as Regional Director, to sanction facilities with either **Full Court Sanction** or **Conditional Court Sanction**. These requirements are for existing and new facilities.

I have sent out forms to be completed by each club to describe your facility, and under the new rules, the facilities have to meet specific guidelines. Depending on the answers to the questions, your facility may qualify with either a **Full Court Sanction** or **Conditional Court Sanction**. Under a **Conditional Court Sanction**, if the minimum requirements are not met, the courts may continue to be used for sanctioned events if a written plan for correction the problems(s) has been agreed to, signed by the club president and is "on file" by the Regional Director. If the corrections are made within an agreed to and reasonable period of time, a **Conditional Court Sanction** certificate can then be issued. For a **Full Court Sanction** your clubs courts must meet all conditional requirements and additional Full Court Sanction conditions including having **full walkways**.

In the NCHPA 22 clubs, we have only 7 that will meet the **Full Court Sanction** requirements, meaning we will have a lot of work to do. I have attempted to have courts grandfathered in as we did a few years ago when the courts were last sanctioned. We did comply with the requirements imposed at that time. One important thing to remember—we have 40 courts at Yolo without full walkways, if we do not put in full walkways, we will not be able to host the State Tournament at that facility.

I have been unable to make any headway, therefore if you disagree with these new court sanction requirements, I ask you to contact the person in charge. ## DATES: October 13<sup>th</sup> & 14<sup>th</sup> LOCATION: Tri-Valley Club

- 1. ENTRY FEE: \$80.00 per team. This is a 2-day event and **pre-registration** is required.
- 2. Teams may be mixed and must have 4 players. Each team may register 1 alternate player to be used in case of injury to an original player.
- 3. All players must be NCHPA members and be a member or associate member of the club they represent. All players must have a minimum of 2 NCHPA, 2006 tournaments on record prior to October 1, 2006 to be eligible.
