It's that time of year again – please don't miss getting signed up for the Championship tournaments that mean so much to so many of us.

CA State Championships – to be held in Bakersfield this year, Labor Day weekend, requires pitching in three (3) CA sanctioned tournaments since the last state tournament to the deadline of AUGUST 1st. Entry goes to Hal Griswold in S. CA.

NCHPA Championships – to be held in Vallejo on OCTOBER 1st minimum of one (1) NCHPA sanctioned tournament before the deadline of SEPTEMBER 17th. **Entry goes to Gail Sluys**

NCHPA Double Championships – to be held in Vallejo on OCTOBER 2nd. No minimum number of tournaments but partners have to be under a maximum combined total average. Deadline

SEPTEMBER 17th. **Entry goes to Gail Sluys**

If you have someone to nominate for the **NCHPA Hall of Fame, the nomination** and information deadline is AUGUST 13th. **Send to Joe Summers.**

Nominations for Scorekeeper of the year are due AUGUST 13th. **Send to Gail Sluys**. Please write up the reason you believe this person should be honored.

As of the end of the first week of July the 2021-2022 NCHPA season has seen 84 tournaments pitched and 9 tournaments cancelled/postponed due to COVID-19 or weather. The 84 tournaments pitched had 1136 NCHPA pitchers entered and 104 non-NCHPA pitchers entered in 210 total classes. There have been 2 games of 80% or more pitched:

Rick Birmingham's 85% game against Steve Goodman in 03-21-086 Lane/Summers Sat. Sep. 25, 2021 in Vallejo.

Rick Birmingham's 80% game against Diane Luiz in 03-22-050 Williams Open Mon. May 30, 2022 in McBean/Lincoln. Good pitchin' Rick!

So in spite of weather and pandemic the 2021-2022 NCHPA season is pretty much back to normal. Stay healthy and keep on a' pitchin'!

As always you club statisticians can make my task pretty easy if you submit your HSMaster files (boxscore files, one file per class, tournament class standings file, and comma-separated-values Results file) in a timely manner. I would like to have them as soon after your tournament as is convenient. Please email your HSMaster files to me at: meanderson99@yahoo.com. And please be sure that the boxscore files that you send are generated in HSMaster as Tournaments, Reports, Results [not Results (Brief)], Text File. Keep in mind that I need member numbers in every file that you send. That means I want the long version, not brief version, of every file. (See the notes below concerning boxscore files and class standings file from doubles tournaments.)

Create the HSMaster files as follows:

- 1) boxscore files, one per class: Tournaments, Play Singles or Play Doubles, Tournament (your tournament number and name), Class X, Load, Standings checked, Box Scores checked, Export; repeat for each class in place of X. Note that for doubles tournaments HSMaster will only produce class boxscore files that do not have pitcher member numbers.
- 2) tournament class standings file: Tournaments, Play Singles or Play Doubles, Tournament (your tournament number and name), Reports, Results [not Results (Brief)], preview if desired, Text File Note that for doubles tournaments HSMaster will only produce a tournament class standings file that does not have pitcher member numbers.
- 3) comma-separated-values Results file: Tournaments, Clean Up, Post Results to Player Stats set to (your tournament number and name), Results File

You may put these files in any folder you like, but C:\HSMasterData is a pretty common folder to put them in. Thanks for all your help. *Mike Anderson*

First I would like to say good luck to all NCHPA participants for the world tournament. I would also like to say good

luck with safe travels to All . Pitch them Ringers.

We are finally here at the halfway point for the 2022 horseshoe pitching season. This season is developing into a great season. It is great that the Covid has calmed down, but we can't forget about it we have to still keep ourselves safe and healthy. Another difficulty that we are having is the price of gas. Hopefully the price will start dropping. as we all know this is a year for bylaw changes if you have any By-Laws that you would like to have changed please get them to Jeff Williams so he can present it at the board meeting. It would be great to have a big turnout at the board meeting. supplies the NCHPA has provided 3650 score sheets to various clubs this year. If your club is getting low on score sheets please get a hold of me so I can get them to your club. A box of 500 sheets cost \$50.00. A bigger topic this year has been the plagues. This is a topic that really needs attention. It is stated in the bylaws that each club will receive, from the NCHPA, two plaques at the beginning of the calendar year for free. If a club needs more plaques The club would have to purchase the additional plaques they need at cost of the plaque. The NCHPA ran out of plaques early this year. We priced different places to replace the Plaques. We found out that it was going to cost from \$26 to \$45 for each plaque that we currently issue. The NCHPA generally purchases 100 plaques at a time. The cost to replace our stock of plaques was going to be anywhere from \$2600 to \$4500. That is a lot of money. In its place the NCHPA purchased 50 boards and 50 header plates that were attached by Casey Sluys, the total cost for the 50 plaques was about \$500. It was a heck of a good price and probably can't be duplicated next time, although we

will try. A big thanks to Casey and Gail forgetting a quick fix on the plaques. If you are going to need plaques the cost for the new plaque is \$15.00. As we go forward we really need to discuss what we want to do about the plaque situation. Please keep in mind this is a by-law changing year.

The Madera club by far has been the club of the year in giving out plaques. They have awarded 10 plaques so far this year and are purchasing another 5 plaques at the end of the month at the Vallejo tournament. That's going to be 15 plaques at the halfway mark, and that is all to new members that have joined the NHPA. A fabulous job for the Madera Horseshoe Club, keep it up. Great job Nick And Dee.

Having had a couple of years of experience now and having it set up fairly well, I'd like to state that I will be running for the 5th vice president of the NCHPA this year. Thank you, *Dave Lane*

First of all a bit about how the NCHPA is structured.

- 1. We adhere to the NHPA National Horseshoe Pitching Associations By-Laws and Rules.
- 2. We have our own By-Laws. (they cannot conflict with the NHPA's)
- 3. We have a set of standing rules in our By-laws.
- 4. A set of Standard Operating Procedures (SOP) have been developed for guidance for the officers.
- 5. There are a set of "Combined Charter Playing Rules" for the California State Championship. Some of these documents are included in this issue. The By-Laws are posted on the website and in due time these other document will also be online, including the Hall of Fame information..

REGIONAL DIRECTOR

The following is what our By-Laws say regarding officers, these can be found on the website at www.nchpa.com

ARTICLE V: Officers

SECTION 5. Candidates for office

- a. Candidates for office may announce their candidacy to the NCHPA President or be nominated at the annual meeting.
- b. Nominees must be willing to serve, be present when nominated or have signified in writing that the nomination is accepted.

SECTION 6. Terms of office

- a. All officers shall serve a two-year term.
- b. The President, the 2nd, 4th and 5th Vice-Presidents shall be elected in even numbered years.
- c. The Secretary-Treasurer and the 1st and 3rd Vice-Presidents shall be elected in odd numbered years.
- d. The newly elected officers shall take office on January 1st of the year following their election.

This being an even year means that the President is up, the 2nd, the 4th and the 5th VP's are up for re-election also. Anyone wishing to run for any of these office please let **Joe Summers and the News & Views editor know.**

When you become an officer you are entrusted as the custodian of these document that hold the Charter together and are directly responsible to update these as necessary. This is simply one of the many tasks that officers signed up for when they entered the position as an officer of the NCHPA. There are a myriad of day to day tasks that can be found in our By-Laws, Standing Rules, and the Standard Operating Procedures.

NORTHERN CALIFORNIA HORSESHOE PITCHER'S HALL OF FAME GUIDELINES

Purpose:

The purpose of the Northern California Horseshoe Pitcher's Association (NCHPA) Hall of Fame is to recognize deserving members who have made significant contributions to the sport of horseshoe pitching at the state level.

Mission Statement:

To seek out worthy people who have set aside years of their personal time to build, organize, promote, fund, and better the sport of horseshoe pitching within the Charter of Northern California whether through their pitching abilities, organizational skills, or promotional efforts.



Committee:

A Hall of Fame Committee shall consist of a committee chairperson along with four other adults chosen by the chairperson and approved by the Executive Board who are active members of the NCHPA in good standing with a minimum of ten years of membership in the NCHPA. The committee chairperson is appointed by the NCHPA Executive Board. The committee chairperson and committee members shall be appointed to terms of three years. There is no limit to the number of terms the committee chairperson or the committee members may serve.

Committee Chairperson and Committee Duties:

The committee and the chairperson shall have the following responsibilities:

- 1) To appoint an additional 4 members of the committee,
- 2) To communicate candidate information in a timely manner,
- 3) To coordinate any discussions
- 4) To distribute the ballots for voting on nominees,
- 5) To collect and count the ballots and communicate the results to the committee,
- 6) To assume leadership in the preparation of any awards and/or certificates

and perform the induction into the Hall of Fame,

- 7) To ensure all recognitions are conducted in a fair and impartial manner,
- 8) To solicit each club in the charter for their prospective candidates,
- 9) To submit the NCHPA HoF nomination form for publication to the Charter's newsletter editor for the 2nd and 3rd issue of a particular year, and to,
- 10) Obtain additional information from the person submitting a name for clarification and enhancing the nominees qualifications.
- 11) To select qualified candidates for the Hall of Fame on an annual basis.

Hall of Fame Nominations:

Membership: Anyone may nominate another person by completing a nomination form, which is available upon request from the committee chairperson. The nominee must have been a member in good standing of the NCHPA for a minimum of 10 years. His/her attitude and initiative should uphold and enhance the image of the NCHPA.

Hall of Fame Categories:

Player – Anyone who has won multiple State Championship titles while pitching in the Men's, Women's, or Elder's Championship Divisions while displaying good sportsmanship and bringing prestige to the sport.

Player/Organizer – Anyone who has won a minimum of one State Championship title while pitching in the Men's, Women's, or Elder's Championship Divisions and has become a worthy and respected Tournament Director, Promoter, Organizer, or Officer at the state level.

Promoter/Organizer – Anyone who through his or her devotion to the sport has made a significant contribution through time and effort to the advancement of the sport of Horseshoe Pitching in an administrative capacity such as Promoter or Organizer of events or as an Officer at the state level.

All nominees MUST meet the criteria listed above in the Membership category and also the criteria requirements in a Hall of Fame category.

Soliciting Nominations:

Each spring issue of the state newsletter will have an announcement of the Hall of Fame nomination process inviting nominations through the use of the nomination form.

Frequency of Inductions into the Hall of Fame:

Inductions of qualified members into the Hall of Fame shall occur at least annually, with frequency at the discretion of the committee chairperson.

Voting Procedures are as Follows:

Each completed nomination form is to be sent to the committee chairperson as soon as possible. Once received by the chairperson, he/she will distribute the nomination information by way of email to the other committee members for review, discussion, and a vote.

Each committee member has a total of 15 points they can use for voting on a 5-4-3-2-1 basis, with a "5" indicating the strongest candidate. No candidate can receive more than 5 points from a single committee member. One's first choice does not have to be a "5" if the nominee is not a strong candidate. The highest score a candidate can receive is 5 points from each committee member for a total value of 25 points. Then we take 51% of the 25 points. Thus, it will take a minimum of 13 points for the candidate to be inducted into the Hall of Fame. In the event of one individual not receiving enough point a re-vote will occur until a member receives the minimum votes. It is possible to induct 2 (two) candidates a year into the Hall of Fame, though under special circumstances more than two may be inducted during one year. The Hall of Fame committee will attempt to induct a minimum of one person regardless of the category, into the Hall of Fame every year at the Charters' annual meeting.

* This committee is not implemented yet, but the NCHPA Executive Council hopes to have this committee in place by mid 2023. In the meantime the Executive Council has assumed the duties of the HoF committee.

On the following pages please find the SOP's. The highlighted paragraphs are the changes to the SOP's from last year. They are effective June 20, 2022.





Northern California Horseshoe Pitching Association Standard Operating Procedures

- 1. Copy fees and postage for mailing NCHPA related materials, will be reimbursed upon submission of your completed expense report/receipts attached, to the Secretary/Treasurer.
- 2. Cost of Stationary, envelopes and flyers for State, Team, Class Tournaments are paid for by the NCHPA.
- 3. The Newsletter Editor shall receive \$50.00 per issue to be paid at year-end.
- 4. Editor will endeavor to use the most economical source of distribution. The NCHPA Newsletter shall be the primary source of communication with the membership and shall include:
 - A. Notices for tournaments schedule requests
 - B. Information regarding new members
 - C. Soliciting nominees for the Hall of Fame
 - D. Soliciting changes/additions to bylaws or standing rules and notifying the membership of same, for voting decisions prior to the annual meeting.
 - E. Soliciting and sharing information regarding junior promotions from the clubs.
 - F. Sharing information and results of publicity and/or sponsorships.
 - G. Sharing statistical information out of the ordinary.
 - H. Sharing any interesting news regarding members.
 - I. All NCHPA officers are required to write an article quarterly to be published in the News and Views.
- 5. The Tournament Director for the NCHPA sponsored tournaments shall receive \$25.00 per day of duty. The State Tournament Director shall receive \$50.00 per day.
- 6. The Schedule Director shall receive requests for tournaments from clubs, by September 1st of every year.
 - A. Schedule Director shall email to each club a form soliciting dates for their tournaments.
 - B. Schedule Director shall compile all information into a workable schedule.
 - C. Schedule Director will keep in mind things such as proximity of clubs, (generally a 100 mile radius between clubs is considered) two-day events scheduled, and size of club when completing the schedule.
- 7. The Vice President in charge of Club Membership and Welfare shall, twice a year E-mail or write a letter, to charter presidents inquiring about the condition of the club and its members.

- 8. The Hall of Fame Committee(the NCHPA officers) Chairperson (NCHPA President) shall solicit from each club candidates for induction into the Hall of Fame and shall decide by vote which candidate(s) will be selected. In the event of a tie in voting the officers will vote again for the two candidates who are tied.
- 9. The Vice President of the By-Laws shall solicit, from each club, changes for the year that they are to be revised.
- 10. The Vice President of Junior Promotion shall solicit each club quarterly to promote juniors.
 - A. This person shall contact the National Junior promoter to gather information.
 - B. The information gathered will then be distributed to each club, with follow up quarterly.
- 11. All NCHPA officers sending correspondence to clubs or individuals shall CC the all other NCHPA officers.
- 12.All Vice Presidents must be familiar with the Presidents duties in the event of an emergency.
- 13. Statistics will be kept of each sanctioned event.
 - A. The method of recording tournament results will be determined by the NCHPA statistician.
 - B. All Charter Tournament Directors or secretaries shall mail or email expeditiously, the results of their event to the NCHPA statistician and the person in charge of updating our Website, Facebook pages or any other social media format.
- 14. The President shall appoint a publicity chairperson
 - A. This person shall appoint a committee of three (3) members to assist him or her.
 - B. This committee will develop a directory of names and addresses of media personal in the cities where the NCHPA has Charter Clubs. (News media is defined as television, newspaper, radio, social media outlets and Park & Recreations departments of the cities).
 - C. This committee will assist Charter clubs by being the initial contact with the news media.
 - D. Contact with the news media for publicity purposes prior to the State, Team and NorCal Tournaments in the area of the clubs hosting these tournaments.

These SOP's are developed as per the NCHPA By-Laws ARTICLE V: Officers: Section Duties of Officers #7. Develop, revise and maintain Standard Operating Procedures (SOP'S) which are the business guidelines and statements of the E.C. and committee duties, travel regulations and expense reimbursement procedures. These SOP's shall be presented annually to the delegates.

California State Tournament Bylaws and Playing Rules

(Revised 8/31/20)

- 1. The Northern California Horseshoe Pitching Association (NCHPA) and the Southern California Horseshoe Pitching Association (SCHPA) shall work in harmony while sanctioning, sponsoring and staging the California State Tournament. Any changes to these bylaws and playing rules must pass by agreement of both Charters. The method used to establish the vote will be as follows. On low impact and/or minor changes, the vote will be the majority vote of the Charter Officers present at the "State" meeting. On major or controversial changes, the vote will be the majority vote of the delegates at the Charter's Annual Business Meeting. If both Charters vote in favor of a proposed change, said change will go into effect on January 1st of the following year unless specified differently in the original motion.
- 2. To be eligible for the State Tournament a player must:
 - a. Be a member of the State and National Horseshoe Pitchers Association.
 - b. Be a resident of the State for a minimum of 60 days.
 - c. Have pitched in three (3) California sanctioned tournaments in the one-year period between August 1st & July 31st. (Note: Juniors need to have pitched in only one (1) California sanctioned tournament)
- 3. These bylaws and playing rules shall in no way conflict with NHPA bylaws and playing rules. NHPA bylaws and rules govern all bylaws or rules not covered herein.
- 4. The State Tournament shall be held during the Labor Day weekend unless an alternate date has been agreed upon by both Charters. A change must allow sufficient advanced notice to let players plan their attendance well beforehand. It shall be the only sanctioned tournament scheduled during this time.
- 5. The NCHPA shall host the tournament in odd years and the SCHPA shall host the tournament in even years unless both Charters approve a change. The Host Charter shall determine the tournament site.
- 6. Any State Tournament that is rained out or cancelled for any reason shall not be made-up at a later date. If the tournament is called while underway and over one-half of the scheduled games for any group have been completed. The tournament for that group will be official.
- 7. The Tournament Director/s shall be from the Host Charter and shall supervise and manage the tournament. The Tournament Committee shall consist of the two Charter Presidents and the Tournament Director/s who shall agree upon playing format and schedule prior to publication.
- 8. The interpretation of the Tournament Committee covering technical points and their ruling on matters not covered herein or NHPA bylaws or rules shall be final. Any protest shall be made in writing immediately, if the occasion arises, and presented to the committee.
- 9. The State Tournament must offer the following divisions: Open Men, Open Women, Elders, Junior Boys, Junior Girls, Cadet Boys and Cadet Girls, (ages 12 and under). Senior Men and Senior Women may be offered at the discretion of the Tournament Director. In each division, the highest percentage group shall be the Championship Class. Additional Classes will be formed if courts and time are available. An effort shall be made to not mix the Open Men and Open Women divisions' championship classes with other divisions; however, if mixed division play is needed, no mixed pitching distances are allowed. All other classes may be mixed with other classes at the discretion of the Tournament Committee. Handicaps in classes having a 12% or greater spread may be used but a Division Title must be determined by scratch play. Handicap % used is to be determined by Host Charter and must not be less than 66 2/3 or exceed 80%.

- 10. The Adult Championship Classes shall have a minimum of six (6) pitchers unless the % spread is considered by the Tournament Committee to be excessive for competitive play; the lowest player in the group will be given the option to stay in the group. The total number of entries and percentage spread shall determine all other class sizes. The Host Charter has the option of running qualifying rounds for any contestants. In all classes below the Championship level that are eligible for money awards, the money should be distributed equally based on the number of entries in the group. When formulating the pitching schedule, every effort shall be made to give all groups the opportunity to pitch two days.
- 11. In all Adult Championship Classes, the games shall be 40 points. The Junior and Cadet Championship Classes will play games consistent with the skill level of the entrants, to be determined by the Tournament Committee.
- 12. Games won and lost shall determine final positions. All first-place ties shall be broken by playoffs and governed by NHPA rules. All other ties shall be broken by percentage. Except handicapped groups where ties for 2nd place will be broken by who beat whom.
- 13. Adult entry fees shall be \$40.00 and must be paid by the entry deadline date. (Juniors do not pay) These fees shall be sent to the Secretary/Treasurer of the Host Charter. There shall be a minimum of two (2) trophies (awards) per each pitching group. The Host Charter shall provide all awards for the tournament. Monetary awards shall be distributed from entry fees at the discretion of the Host Charter.
- 14. All junior pitchers shall be recognized with a State Tournament participation award or trophy. Each Charter shall be responsible for having the Juniors Perpetual Trophies present at the State Tournament.
- 15. The first-place trophies in the Championship Classes shall be larger and more significant than the first-place trophies in open classes. Junior participation awards shall be smaller and less significant than second-place awards in any other class.
- 16. Pitcher's entering averages shall be determined by "Eshoe" or each Charter's official statistician's averages, whichever is most current. Averages on record as of August 1st should be used.
- 17. Each contestant shall pay the scorekeeper \$1.00 per game. Judges will be paid by collecting \$1.00 from each contestant at the start of each session, each day of pitching and divided between the judges on duty during that session.
- 18. All contestants shall be appropriately and completely attired at all times while on the courts. This is to include appropriate footwear. No open-toed shoes are allowed. All contestants must have their name printed on the back of their shirts in a professional manner. Names hand-written with a felt pen or written on a piece of cloth or paper and attached to shirts are not acceptable.
- 19. The Host Charter shall furnish nameplates for the scoring devices being used.
- 20. Host Charters may elect to have a handicap tournament in conjunction with the State Tournament with a \$5.00 entry fee. This is optional for the contestants.
- 21. A stand-by list of late entries may be used to fill in groups at an additional fee of \$10.00, and must comply with original entry rules to be admitted.
- 22. Host Charters must have State entry applications distributed by January 1st and information packages distributed to the Guest Charter by June 1st.
- 23. A meeting of State Officers of both Charters shall be conducted during the State Tournament at a time set by the Host Charter President. Charter Officers are to send, in writing, to the Host Charter President, by the entry deadline, any subject they would like discussed at the State Officer's Meeting. (Snail mail or email is acceptable).
- 24. Opening ceremonies are to be conducted between shifts near mid-day Saturday. The ceremonies should, at a minimum, honor the Flag, Deceased Members, any Special Guests, and Charter Officers and in general be a dignified presentation.
