The club is called the Dead Ringers Society, and Steve is doing things a bit different there and it looks to be working great. Mostly they have tournaments on Sundays about once a month + or -. As opposed to most places these days, he runs the juniors and new pitchers *first* -- and with *shorter* games. The goal here is to get them thru the fun quickly (and get the 2nd round started sooner), not leave the rookies hanging around all day, thereby giving them a negative impression and then never to be seen again.

He has the experienced players keep score and mentor the new players along the way, which seems to really make a positive impact on their overall experience. The courts are laid out beautifully and the view is second-to-none. There are plenty of hotels, restaurants and shopping right there in Stevenson Ranch. Steve has made it a priority to grow the sport and thereby encourages his new players to stick around and watch "the big show" when the better players take to the pits. The horseshoe gods have smiled onto those new pits, clearing the skies just in time for each tourney so far and they've been getting nice sized crowds, with the number of *junior* pitchers and *new* adult members

jumping each time. The last tourney had 9 Jr's in one class and 1 more high % jr. mixed with all the high % 30 ft. pitchers. The 40 ft. pitches have their own class -- thereby allowing 3 Tournament Champions that day. Everybody seemed to have a great time, as their local Starbucks Coffee provides it free for each tournament, and they have a local restaurant set them up with lunch. Statistician's Report

Well so far this year we had one tournament in February cancelled, three tournaments in March cancelled, two of which are rescheduled for March 20th and 21st. Sacramento had two tournaments on the 13th and 14th but I do not have the results yet. Hopefully the weather will clear up and we can get more tournaments in.

Twenty-one NCHPA members pitched in five tournaments in Arizona and Southern California so far this year. In these 8 tournaments, our members made 2,276 ringers and pitched 6,410 shoes. This made for an overall ringer percentage of 35.51%. David Loucks had the highest tournament average of 64.00%. The results posted for that tournament did

not show the high percentage games. Everyone who pitches in other states should let me know if they pitch an 80% or above game.

The Marvin Sanders Open Tournament at Tulare on February 28th had 32 pitchers. Of those, 22 were NCHPA members, 9 SCHPA members and one pitcher from Oregon. Congratulations to Bob Midkiff who pitched the high percentage game of 71.88% and the high Tournament of 65.18%. Verdan Zelmar won first place in the second group with a 34.82% average and a high game of 53.13%. Gilbert Gallegos won first place in the third group with a 33.48% average and a high game of 59.38%. Eddie Curtsinger of the SCHPA won first place in the fourth group with a 26.34% average and a high game of 34.38%. Total ringers in this tournament were 1991 and total shoes pitched were 7176 for an overall average of 27.75%

Several people have called me and asked why they pitched 224 shoes in this tournament. There were 8 people in each group and 40 shoes would make the tournament too long. Thirty-two shoe games shortened the time and allowed the games to end on the same end of the court they started on. **Lee Roy Lassiter**

CALIFORNIA Pitching History

Southern California has made horseshoe pitching one of its favorite sports ever since it has been a popular tourist resort. For years the game was played with no uniform rules.

A Tourist Club was organized in 1900 at Long Beach, with a membership of some 600, composed of members from 25 states and Canada. Mr. W. S. Montgomery, an attorney, was the leader. The interest in horseshoe pitching was kept alive by clubs in some 15 or 20 different places among which were Los Angeles, Santa Barbara, Redlands, Long Beach, Glendale Pasadena, Pomona, etc. Very hotly contested games were played for a number of years between Long Beach, Pomona, Pasadena and Redlands. From these games there was developed a number of very good pitchers.

The best score on record at that time was made by A. Bruce an 18-year-old boy of Glendale, and Denny Wilkinson of Long Beach, who each pitched 50 ringers in a series of five 21-point games. No record was kept of the number of shoes pitched.

Through the efforts of Geo. E. Krinbill, secretary of the Long Beach Tourist Club, the Golden State Association of Horseshoe Pitchers was organized on June 12, 1920, with W. A. Hoyt, Long Beach, president; Geo. E. Krinbill Long Beach, secretary; H. L. Smith, Pasadena, assistant secretary, and T. Holman, of Klendale, treasurer. Until this organization, the game had never been played by standard rules.

The game has continued to become more popular

until at present there are a large number of clubs in the state, some of the more prominent of which are located at the following places: Covina, J. R. Beecker secretary, 592 N. 5th St.; Santa Monica, C. H. Prior Secy., 1055 21st St. : Long Beach, Geo. H. Cleaver, 2409 E. 5th St.; Los Angeles, South Park, Geo. Bauder, Secy., 51st and Towne Ave.; Los Angeles, Exposition Park, H. C. Cammert, 602 W. 40th Place; Glendale, C. F. Godfrey, Secy., 325 N. Orange St.; Pomona, Thos. Awrey, Secy., 520 E. 3rd St.; Whittier E. V. Ware, Secy., Route 1; Riverside, F. W. Knox, Secy., K08 Walnut St.; Huntington Park, O. Gersuld, 6317 Seville Ave.; Haynes, Standard Oil Club, F. H. Gilbert, Secy., Box 107.

Following is the data about the eight state tournaments that have been held:

1921- Glendale, November 25 and 26, at H. S. Athletic Field. There were 52 entries in three divisions. W. R. Bradfield, Long Beach, won the state championship.

1922- Long Beach, Sept. 28 to 30. There were 66 entries in six events. G. J. Milligan won the championship; Bradfield and Galloway, Long Beach, were the team winners.

1923- Santa Monica, H. S. Athletic Field; 80 entries, 9 events. Robert Nunn, Oxnard, won the championship; team winners, Porter and Anstey, of Glendale.

1924- Pasadena Central Park, August 27 to 29. 100 entries, 9 events. Robert Nunn, Oxnard, champion; team winners, Bradfield and Galloway, Long Beach.

1925- San Diego, Army and Navy Y. M. C. A Field, August 26 to 28. Largest number of entries yet; figures not available. Robert Nunn, Oxnard, champion; team winners, Porter and Anstey, Glendale.

1926- Los Angeles, Goodyear Rubber Co. Park. Large entry list. Dean Brown, Riverside, champion. Team winners, Hansen and Olsen, Fresno.

1927- Pomona. Sept. 21 to 23 Los Angeles County Fair. Large entry list, 9 events. S. L. Hiatt champion; team winners, Lyle Brown and Foster, Pomona.

1928- Huntington Park club Grounds, Sept. 26 to 28. Large entry list; 9 events. Dean Brown, champion; team winners, Walker and Claypool, South Park Club, Los Angeles.

Each succeeding meet has been better than the preceding one from the standpoint of horseshoe pitching. These tournaments have popularized the sport greatly by having different events. At the 1928 meet there were nine events, no person being allowed to enter more than one. Entry fee of 50 cents was charged each entrant.

Event 1 had 12 prizes, totaling \$152-\$20 and a \$40 French plate mirror and a championship gold medal going to the winner. 150 shoes were pitched for the elimination, the 32 men making the highest number of points competed for championship in Class A.

Event 2-The 12 men making the next highest number of points competed in Class B for \$84, divided into nine prizes, with three other merchandise prizes. 50-point games were played.

Event 3 was for teams confined to one team from each club belonging to the State Association. \$68 in prizes and silver medals, and state banner for one year to winners.

Event 4-For men of 45 and under 60 years of age;

each pitching 150 shoes. Points win. \$39 in five prizes.

Event 5-For men 60 and under 75 years of age. 100 shoes, points win. \$26 in five prizes.

Event 6-100 shoes points win; for men who have never made over 25 ringers in five 21-point games. \$18 in five cash prizes. Pair of shoes for sixth prize.

Event 7-"Boys" 75 years old and up ; each man plays every other one 21- point game. \$23 in four cash prizes, and box of cigars for fifth prize.

Event 8-Youths 13 years and under. \$10 in four cash prizes. Each plays every other one 30-point game.

Event 9-Consolation for those eliminated in events one and two. Each pitch 50 shoes. Points win. Eight merchandise prizes.

The present officers of the California Horseshoe Pitchers Association are: President, W. H. Smith, 858 10th St., Santa Monica; Vice President, W. R. Bradfield, 1570 Elm Ave., Long Beach; Secretary-Treasurer, Glen B. Porter, 344 Salem St, Glendale.

Geo. E. Krinbill, who had held the office of secretary in the State Association since it was organized and largely through whose energy and efforts the organization has been built up, and the interest in the tournaments has been sustained and increased, passed away in November. Mr. Glen Porter Glendale, takes his place.

The Olympic games are to be held in California in 1932, and the State Association is planning on entertaining the same year, if not before, the National Tournament. **February 1, 1929 by D.D. Cottrell**

HERE'S A GOOD STORY ABOUT GEORGE!

George Greeott of Windsor turns 100

April 30, 2010.

Here is a recent glimpse of this remarkable man.

Do you know about George's 2010 tree? In the heavy January storms a huge oak fell behind his barn. Lucky it fell away from the barn! The tree went across a path near the lake and fell into a couple of other big trees, kind of hanging up in their branches. George at first thought he would have to hire a man with a crane to come in to tackle taking down that tree. The tree was that big!

When the weather cleared George went out and trimmed away some of the branches he could reach. That was several days' activity. The tree's big skeleton was revealed. Soon a neighbor came over and sawed the trunk getting it onto the ground. The tree was in a terraced area and not the easiest place for footing. By the second time I saw it George had removed almost all the leafy parts of the tree.

George's immediate concern was a couple of big branches that were still hanging up high in the other trees. He estimated that he could make a very long steel hook and attach that to a chain which he could use to pull a big branch down if he hooked the chain to his four wheeled golf cart. I cautioned about safety of such a plan. Could tell he was determined to do it. Suggested he at least have someone on the premises in case he didn't jump out of the way fast enough. He didn't answer. But later that afternoon he proudly phoned to tell that he had accomplished his objective. No problem.

His chain saw friend came for another session of reducing trunks to fire place lengths. George filed the saw chain so it would be sharp. Meanwhile **George had used his handsaw to reduce all the limbs of 3 and 4-inch diameter to firewood lengths.** There were two huge piles of those limbs. He considers using the hand saw to be "good exercise."

Still there were lots of logs that needed to be split. A neighbor has a splitter. But the terraced terrain would not accommodate a splitter. So George rolled those logs to the tailgate of his utility vehicle and carted them maybe 75 feet to a flat area where they can be split and stacked. In a matter of about three weeks of beaver like activity George conquered that tree including raking and cleaning up the debris. He loved every minute of his accomplishment all the more so because he will be one hundred years old on April 30, 2010 **Written by Cathy Landis**

Kenneth Karl Schulze, a meticulous record keeper who worked four decades for the U.S. Postal Service, also had a yen for pitching horseshoes and raising thousands of chickens.

“He had a good life,” said his son, Herman Schulze of Santa Rosa, who followed his father’s footsteps as a local mail carrier and worked in the family’s chicken houses, which held as many as 10,000 birds.

The elder Schulze, known as Kenny, died of congestive heart failure on Friday at a Santa Rosa assisted living facility, one day before his 94th birthday.

His mind remained sharp until a few weeks ago, and Schulze held onto notes dating back 30 to 40 years, covering matters such as his daily activities, his blood pressure, auto mileage and light bulb changes.

“He kept track of everything,” his son said. “He was a bean counter.”

An avid reader and a math whiz, Schulze could calculate percentages in his head and kept a mental record of his only child’s behavior. “He remembered all my shenanigans,” Herman Schulze said.

But he also was a devoted stepfather, who married Herman Schulze’s mother and adopted him when he was 5. “Just before he died, I told him, ‘Dad, you did a good job. I thank you,’” Herman Schulze said.

Born in Flatrock, Ind., the elder Schulze moved to California with his family in the early 1920s, residing in Orange and Humboldt counties before settling in Santa Rosa. He attended the now-defunct Todd Grammar School at Todd and Stony Point roads and graduated from Santa Rosa High School in 1932 at age 16.

Schulze began pitching horseshoes and raising chickens on his family’s ranch on Millbrae Avenue, and both turned into longtime passions.

Raising chickens “was kind of the love of his life — other than my mom,” Herman Schulze said.

His own flock, at a 36-acre Olivet Road ranch he bought in 1959, grew as large as 10,000 chickens before he quit the poultry business in 1965.

Schulze went to work for the Postal Service at age 18, starting out as a letter carrier and working his way up to director of finance for a North Bay region stretching from Santa Rosa to Willits.

He delivered mail in Santa Rosa’s McDonald Avenue neighborhood where, years later, his son walked the same sidewalks with a mail bag. The elder Schulze retired from the

Postal Service in 1977, after 42 years. His older brother, the late Herbert Schulze, was a Santa Rosa postmaster.

Schulze served in the U.S. Navy during World War II, stationed at Mare Island, and remained in the Navy Reserves until 1951.

After his wife Eula’s death in 1987, Schulze became more engrossed in horseshoes, joining the Sonoma County Horseshoe Pitching Club based at Doyle Park. “He got hooked,” his son said, traveling to tournaments in the Central Valley and the Sierra and competing in national seniors tournaments.

Schulze pitched ringers at rate of about 60 percent, his son said.

He and his wife also were league bowlers at the old Continental Lanes on Mendocino Avenue.

In addition to his son, Schulze is survived by three grandchildren and a niece. He was a member of the Nazarene Church in Santa Rosa.

At his request, no services will be held and burial will be private. Memorial donations may be made to Sutter VNA & Hospice, 1140 Dutton Ave., Santa Rosa, 95401.

A Special Man

There are many accomplishments Ken Schulze attained in his horseshoe life and all of you who knew him know how much he loved and supported horseshoe pitching.

There is one special story I would like to share (Cont. next page) about Ken. When my dad passed away and I came back from his funeral in N.J. Ken and I were talking at the courts and I said, “man it’s hard – now at 49 years old I’m an orphan”. Ken immediately gave me a hug and said, “I’ll be your dad”. From that day on we had a special bond and as many of you know I even called him “dad”.

Ken lived up to his word and often reminded me so much of my dad. At our 1999 Sonoma County Championship tournament he and I were tied for first place and we had to pitch a playoff game. Ken gave me a father/daughter lesson that day: he won the playoff and became the Sonoma County Champion of 1999. Like my real dad he made me proud.

My heart hurts to have him gone – and I will miss him. *Gail Sluys*


